THE SCHOOL ANNUALLY PROVIDES APPROXIMATELY \$2.7 MILLION IN FINANCIAL AID AND SCHOLARSHIPS ACROSS ALL PROGRAMS TO NEARLY 60% OF ITS STUDENTS. SETTLEMENT HAS BEEN SUCCESSFUL IN RECRUITING AND RETAINING CREDENTIALLED AND EXPERIENCED FACULTY.
